The Volume of Shrimp Exports Rose 33% by August of This Year

The sale of shrimp to the world keeps its first-place ranking among non-oi-l/non-mining exports. According to the Ecuadorian Federation of Exporters (Fedexpor), the increase in export volume from January to August of this year was on the order of 33%.

Sales from January to August amounted to \$5.085 billion. China, the main buyer of Ecuadorian shrimp, made purchases for \$2.707 billion in that period, representing a 100% increase in monetary terms and a 67% growth of its imports. Purchases from the United States, totaling \$1.047 billion, were also on the rise, while the European Union weighed in with \$747 million and Colombia, \$38 million.

Ecuador-Mexico FTA Enters Decisive Week with Shrimp in the Spotlight

Disagreements continue in free trade agreement (FTA) negotiations between Ecuador and Mexico, where the delay in signing turns on the issue of Ecuadorian shrimp.

A key purpose of this agreement is Ecuador's full membership in the Pacific Alliance, a major economic bloc in Latin America currently comprising Chile, Colombia, Mexico, and Peru. As the parties have stated in their various meetings, membership would open up new trade routes for the country with the Asia-Pacific region. However, according to statements over the last few weeks by Julio José Prado, Minister of Production and Foreign Trade, although agreements have been reached on 99% of the points discussed, the shrimp issue is keeping the signing of the FTA the air.".
